### 1. Grant of Lease

### 2. Incorporation of Old Lease

2.1 The terms conditions and covenants contained in the Old Lease shall apply to the Property and be incorporated into this Lease.

2.2 If there is any inconsistency between the provisions of this Lease and the Old Lease the provisions of this Lease shall prevail.

### 3. [Exclusion of security of tenure]

3.1 The Tenant confirms that he/she/it was aware of this Lease (or as the case may be before the Tenant entered into this Lease) the form set out in schedule 1 to the Landlord and Tenant Act 1954 (the "2003 Order") Order 2003.

3.2 The Tenant confirms that he/she/it has made a [declaration in the form set out in schedule 2 to the 2003 Order.]

3.3 The Tenant confirms that he/she/it has made the declaration on the Tenant's behalf did so.

3.4 The Landlord and the Tenant agree that the provisions of the Landlord and Tenant Act 1954 are excluded by the provisions of this Lease.

### 4. [Termination by Landlord]

4.1 The Landlord may terminate this Lease at any time [after <<insert date>>] by giving to the Tenant notice of <<insert period to terminate lease e.g. 3 or 6 months>> notice. The Tenant waives any rights of action or claim for breach of any of the provisions of this Lease.

4.2 The Landlord shall not be liable for any payments of rent that relate to a period after the date of termination of this Lease.

**5. [Termination by Tenant]**

- 5.1 The Tenant may determine this Lease at any time [after <<insert date>>] by giving to the Landlord notice of termination for a period to terminate lease e.g. 3 or 6 months>> notice at any time but without prejudice to any rights of action which the Landlord may have for breach of any of the provisions of this Lease.
- 5.2 This Lease shall only be terminated by notice given by the Tenant if the Tenant has paid all the rent due up to the date of determination and gives up possession of the Premises. The Landlord shall be entitled to withhold no continuing underleases.
- 5.3 The Landlord shall be entitled to recover payments of rent that relate to a period after the determination of this Lease.
